

TAPCON CAN COOLER AND T-SHIRT SWEEPSTAKES

OFFICIAL RULES

1. **Sponsor.** This sweepstakes is sponsored by Illinois Tool Works Inc., an Illinois corporation, the headquarters of which is located at 155 Harlem Ave, Glenview, IL 60025 (“**Sponsor**”). By entering, you agree to these official rules and the decisions of the Sponsor, which are final and binding. This contest is not sponsored, endorsed, or administered by Facebook.

2. **Eligibility.** The Tapcon Can Cooler and T-Shirt Sweepstakes (“**Sweepstakes**”) is open only to individuals who are legal U.S. residents, 18 years of age or older with pre-existing Internet access and Facebook accounts. Employees of Sponsor, and their respective parents, subsidiaries, agencies, and affiliated companies and their immediate families are not eligible.

3. **How to Enter.** NO PURCHASE NECESSARY TO ENTER OR WIN.

You must complete all required information to be eligible to enter to win a prize. Entries must be submitted between June 13, 2019 at 12:01 am and June 20, 2019 at 11:59 pm Central Time. Normal Internet access and usage charges imposed by your online service provider may apply and will be your sole responsibility. All information provided is provided to Sponsor, and not to Facebook.

Limit one sweepstakes entry (“**Entry**”) per person. Additional entries will be disqualified, and Sponsor reserves the right to disqualify any person that submits multiple entries.
